16 Objections to COGR Practices & Doctrines

I was surprised to say the least when I was asked to meet my Pastor, Henry Hildebrandt at this office on July 22nd to find out that I was banned from the all meetings of the Church of God (Restoration). I was told by Henry that the decision was made by Danny Layne, Ray Timsman, and himself with the approval of my dear wife Susan Mutch, all ordained ministers of the Restoration. Their pictures are above listed from left to right.

At the time Henry Hildebrandt told me I was no longer welcome to attend meetings I had been under church discipline where I had been considered a visitor since Feb of 2007. This was for telling Henry Hildebrandt that I felt their anti-medical teaching where they teach the sisters need to be willing to die before getting medical help in child bearing and if they do go for life saving medical help it is sin – was ludicrous.

When Henry Hildebrandt informed me that I was no longer welcome and banned from all meetings he neither made any attempt to show me the errors of my 16 objections to Restoration practices and doctrines nor did he deny any of my points. While in the office with him I brought up his teaching that we are to marry the church (meaning the Restoration) and told him that I considered it amateuristic and to be spiritual polygamy but he didn't want to discuss it. I also let him know that I felt he was under the influence of a sectarian spirit and that he needed to stop professing to be anti-sectarian.

I had emailed Henry Hildebrandt the 16 objections to Restoration practices and doctrines at his prompting when in his email he noted that “most of the time I have found that when a person is in disagreement with the body on a mayor point, there are usually other areas that need attention”. I fine it strange that in the email that I responded to Henry Hildebrandt told me “if the whole body is wrong then you have an obligation to show us by the Bible...” yet in the meeting he made no attempt to show me by the Bible where I was wrong nor has he responded to the email I sent him the 16 points in. I guess only I have an obligation to show them their errors they don't have any obligation to show me mine – and that I will do!

I talked to my wife shortly after and told her what had happened she promptly told me “Bob you're not saved”. When I answered

hurt me physically because I had left the Restoration. Of course I reproved him and told him that what he was told are lies and I had be put out but he didn't believe me. He told me that he thought I was smarter than that to leave the church, and how much he was disappointed in me.

To be fair to the Restoration, this young man is no longer attending regularly at their meetings. He was raised in a troubled home and although he is smart he seems to be a bit socially dysfunctional.

I had one of the Restoration people ignore me completely (it could have been he didn't see me, but his children waved to me), and another march away with his nose stuck in the air not willing to give me the “time of day” when I said hello to him.

Just to represent the Restoration fairly, I feel like many of the more spiritual ones have been very polite and kind to me and even honk their horn at me when they see me and I hadn't seen them.

Anyways, you get the idea.

When I originally wrote the what became the One True Visible Church (OTVC) Teaching article, it was directed for the most part at the Holdeman group and not the Restoration. My inspiration to write the article was not gained from my experience with the Restoration, but from what I was seeing the Holdeman group was doing to their members. It was an MO there that was a clear pattern.

While most Holdeman members will not be able to see clearly what the Holdeman ministries are doing to the people they put out, they should be able to see clearly how I have been treated wrong.

This is human. I am still not able to see clearly all the wrong in the Restoration that people insist is there, but oh how clearly I can see it in the Holdemans. At times, I have clearly shouted “cult” when I have heard some of the things that they have been accused of doing.

More could be said, but that is enough for right now. I truly feel sorry for these dear Restoration people that are so deceived by the OTVC false teaching and I am horrified by the terrible fruit it is producing in them.

May God save this world from this abominational teaching!

While the first paragraph is what they say, the second paragraph is what they mean. If you don't have the key to what they are saying you would be misled.

I can see clearly that many of the Restoration people are Christian bigots but especially the ministry. The people are also raising bigoted children and young people, and are producing bigoted converts. When I say they are bigots I mean they are intolerant with other Christians that believe different than them and if those that differ with them don't change to their version of doctrine and standards they will not accept them as Christians.

Bigot: a person who is utterly intolerant of any differing creed, belief, or opinion.

I think it is pretty intolerant to tell others they are not saved and going to hell because you don't agree with them in non-essentials teachings and practices or you don't agree that their small 10 to 15 congregations are the only true congregations and all other congregations are of the devil. (They only do this to those that have come among them and have had time to hear that they consider the truth. They don't act this bigoted toward those who have not heard their version of the truth.)

In particular the Restoration ministers have acted very bigoted toward me. When I let them know that I didn't agree with their end times teaching that the body of Christ was restored in 1880 according to the books of Daniel and Revelation they promptly banned me from all meetings and made no attempt to show me my error. Further they told me I was not a Christian, prated against me with malicious words slandering my Christian experience to others by telling them I was a child of the devil. By this they show that they are under the influence of the same sectarian spirit that Diotrephes (3Joh 9-10) was effected by, forbid the brethren to fellowship me with the threat of being cast out of the church.

I have had one 8 year old and a 13 year old from different Restoration families tell me I am not saved (two different families that live close to my home). Some of their children now will not wave at me when I see them, rather they just stand there and look at me with a serious look.

Just 2 days ago, I had one of their backslidden young people abuse me verbally (used the F-word numerous times), and threatened to

the phone the next day I got Danny Layne who was calling for Susan and had a short conversation with him. When I told Danny Layne that casting out a Christian out of their assembly over disagree in non-essentials is sectarian and when I let him know in my opinion he was operating under a sectarian spirit he let me know that he didn't think I was saved. When asked what my sin was Layne told me that I didn't believe the Restoration was prophetic which is one of their cardinal teachings.

Danny Layne also told me that this was not a top down action the ministry had taken against me but that there had been a number of members that had been concerned about me for some time and especially since I had contacted 911 during a panic attack I have back in early 2007. (I am not giving word for word the conversation I had with Danny Layne but giving it to the best of my remembrance.)

Members going to the Restoration ministry with concerns about other members that are not carrying the party line is part of the culture of the Restoration. When some one goes against what the ministers teach the other members wonder what is wrong with this person and they often express their concern to the ministry by asking if that person is still saved. Shortly after the issue of phoning 911 in early 2007 I had one local member of the Aylmer congregation ask me if I was still saved, and another me asking me almost weekly how I was doing spiritually.

Since I was cast out on Tuesday July 22nd, I have not received one call from a Church of God minister nor a call from any members of the movement concerning my state or how I am doing. It seems they have cast me out and washed their hands of me. May the Lord have mercy on their souls. Inasmuch as you have done it unto one of the least of these my brethren you have done it on to me Jesus said.

I am glad to report that by the grace of God I have a heart full of love for all of them and while it is difficult for me to understand how some one can be saved and take such unscriptural action against another Christian I am more than willing to hope all things and endure all things and pray that the Lord will show them the error of their way. I pray for them daily and want to say by the grace of God I am completely free from all bitterness or any get-back spirit.

For those that are wondering why I am publicly posting what should be a private matter I would like to answer that question clearly and concisely.

1. I feel I need to go on record and provide documented information showing why I was cast out of the Restoration as the Restoration ministers are so bias against those they cast out they tend to slander them and not provide a balanced account of what really happened.
2. I feel that prospective members need to be made aware of what they are getting into when they join the Restoration. The practice of hiding doctrines from prospective members and new members is unfair and in my opinion not in good faith.
3. By taking these issues which should be dealt with in a private matter public, I hope to force the Restoration ministers to address these issues for the betterment of the other members of the Restoration movement. You may understand this point better then you read my 16 objections below.
4. I want a place that I can reference people to that want to know the objections that I made that got me cast out and banned.

The following are the 16 objects to Restoration practices and doctrines as I sent them in my July 16th 2008 email to Henry Hildebrandt numbered in the order I emailed them to him and reorganized under the following five headings. It was for holding and making these objections they cast me out of their assembly and told me I am no longer saved.

End Times:

3. that the Restoration will never compromise;
4. that no Christians will be left in any denominations and they will only be found in the Restoration before the Lord comes back;
5. the back dating of the fall of the church to 270 by holding that the three days and a half of Rev 11 are 350 years and that God purposely using the day symbol in this way so that many people would not accept the 270/1880 dates;
8. that the Restoration is prophetic and therefore can do no wrong;

Authoritarian Ministry:

1. Believe what ever the ministry teachings without questioning it;

"We found John Doe to be an unteachable and proud person. We tried to help him the best we could. He was not living right in his home and his wife doesn't feel like he was saved. There also were many people in the local congregation that knew his life and for a long time wondered if he was saved. He was divisional and causing problems in the congregation and we just had no choice but to ask him to leave."

Let's translate that.

"As we are the one and only way, any body that doesn't believe our church is the one true visible church is proud and unteachable. So as John Doe doesn't believe we are the one true visible church he is proud and unteachable. We have managed to convince John's wife of the one true visible church teaching and how it is true humility for her to submit to our ministry and what ever we tell her even if she doesn't understand.

So when we told her John had a proud and unteachable spirit because he doesn't believe that most important teaching of the one true visible teaching it was easy for her to accept this. Also we have helped John's wife to see that John is deceived as he is not accepting us as the one true visible church. All his praying, Bible reading, and tract work shows he has a religious spirit. As John's wife has proven her humble by unquestionable obedience to the ministry, and John is proud, unteachable, and deceived, clearly the problems they are having in the home are all John's doing.

We have told John's wife in some cases it would be wisdom to let the people John is trying to influence away for the truth know that she feels John is proud and unteachable, has been the cause of many problems in the home, and that he seems to have a religious spirit. This way John's wife can say that it is not all about one true visible church issue, but that John was not living right in the home.

We have taught the people in our movement to question a persons salvation if they don't praise our church and our ministers, accept the one true visible church teaching, and believe what everything we teach them. Therefore, many of the brethren have been wondering whether John has been saved for a long time. Even if he doesn't spread his differences to others, just the fact that he disagrees means he has a divisional spirit. People that are of a divisional spirit will put a damper on the meetings and hinder the working of God. Due to these reasons we asked John to leave."

true visible church". May God deliver us all from such a monster!

So, with love towards all and malice towards none, this warning is issued to all church groups - not just the Restoration - that teach that they and they alone are the "one true visible church". The excluding of others from Christian fellowship over non-essential teachings and pretending to have the power to put Christians out of the body of Christ is sectarian at best, arrogant, bigoted, and sinful at the worse. May God have mercy on the ministry of all groups that do these very things.

Warning: There are three groups in Aylmer that hold the OTVC teaching and those that are considering associating themselves with any of these groups should to be aware of what they are getting into. The following three groups hold this OTVC teaching:

Jehovah's Witnesses Kingdom Hall -- Corner of 73rd Hwy and Glencolin Line, Aylmer.

The Church of God Meets Here -- 73rd Hwy, Just South of The Kingdom Hall, Aylmer.

Church of God in Christ Mennonite -- John Wise Line and Hacienda Rd in Luton (South of Aylmer).

One True Visible Church (OTVC) Fruit

I think one of the keys that will unravel the OTVC teaching is to have it applied to you. To me, this was a big shock! I believed that I would never be put out of the Church of God Restoration, as I was a Christian - and they wouldn't put Christians out.

When I was put out of the Restoration, they started slandering my Christian name with half-truths and twisted facts by telling people I was not saved. It was then that I realized that this is what they did to others. I clued in that the twisted rumors they were telling others about me were the same twisted rumors that were told to me about others they had put out while I was still with them.

Here is an example of what I mean by half-truth twisted rumors:

2. follow counsel given by the ministry even if you don't understand it;
6. that not keeping Restoration rules is sin and causes you to lose your salvation;
7. ministers going on Internet while telling others it is sin to do the same;

Movement Orientated:

10. teaching that when you praise the Restoration you are really praising Jesus as the Restoration is Jesus' body;
11. attributing the accepting the Restoration as the church, obeying the Restoration ministry, and keep all the Restoration rules as spirituality verses having a deep devotional life, an active burden for souls, a consistent increase in the fruit of the Spirit, and freedom from carnality;
12. teaching and encouraging members to praise the ministry verbally in meetings;
13. teaching that we are to be married to the Restoration;

Non-Conformist/Unwritten Rules:

14. teaching a standard of dress that is not based on modesty only but also based on distinction for the sake of being distinct and noticed;

Ethically Issues:

8. being less that forthcoming and purposely leaving authorities with wrong impressions concerning deaths where members refused medical help;
9. the hiding of divorce/remarriage and the anti-medical teaching from visitors and new members;
15. a low standard of sanctification that allows for carnality in the sanctified;
16. and of course the anti-medical teaching.

Email to Henry Hildebrandt

Note: The following was a responding to an email Henry send me and I cut and paste his points into my email and they are in italic. This makes it easier to see what I am responding to. This was the way the original email was set to Henry.

Dear brother Henry,

I sorry I took so long to answer your email. I have done my best to carefully and prayerfully answer your questions and to be honest and up front with you and where I stand. I wrote this reply on May 12th (a week after you I received your email) and I spend the last 2 months meditating about what I wrote and if I should change anything or add anything.

I took the day off today from work to fast and prayerfully consider what I wrote and have made a few changes and added the list of things that I would respectively disagree with that the Restoration teaches. While I think we need to be careful to not be rash in what we say I feel it is best for all to be upfront and honest about how we see things and where we stand on issues. I have always tried my best before the Lord to do this even when it has been to my own hurt. Honesty and openness with the brethren is truly the best policy.

I have responded to your questions with my many faults, failing, lacks and weaknesses before me. I lay no claim to a deeper revelation than any one else and for some of the things I disagree with I have no answers. I have no axe to grind, no hobby to ride, and little interest in anything that doesn't directly relate to personal holiness and my increasing in the grace of God. While I have answered your questions clearly, directly and perhaps in some cases forwardly I want you to know I shy away from confrontation and take no pleasure in disagreeing with you. I trust you will receive this response in the spirit that it has been written.

>>>Do you feel that it is possible to be in perfect unity with us and yet at the same time disagree on a mayor doctrine?

I am taking you here to mean unity of the Spirit as if you were meaning unity of teaching or doctrine the question would be rhetorical. It would depend on what you are calling a major doctrine. I presume you are referring to the standard taught concerning what Restoration members are permitted to go to the doctor for. I wouldn't consider rules that dictate which members are allowed to seek medical care and what they are allowed to seek medial care for to be a major doctrine.

If you consider this a major doctrine then the restoration just changed a major doctrine when your start requiring all children and young people under the age of 18 in Canada and US to go to the

When I was cast out of the Restoration, I was basically told that if I wanted to come back I would need to recant my 16 Objections to Restoration Practices and Doctrines and get saved again. The Restoration would also hold that there is no way for me to get saved outside of their group. Read my 16 Objections and you will find I only objected to non-essential practices and doctrine.

It is very sectarian and even sinful to use the threat of putting someone out of what they are calling "the one true visible church" and thereby damning that person to hell to get them to accept what they are calling the "truth". This is done to get a member to accept their non-essential teachings (like the Restoration's anti-medical or marrying the church teaching), or to accept them as the "one true visible church".

The OTVC teaching appears to be used as a way to beat the sheep into a uniformed outward standard, uniformed doctrinal standard, and to get them to bow to the leaders that are many times carnal, rude, overbearing, and accusative. It seems that 'unity' can't be obtained by the Spirit of God, so it is gained by threatening to expel people from the OTVC and hence to doom them to hell.

You dress like us, you believe like us, you bow to our ministers no matter what they tell you to do, or we will sideline you and apply pressure using spiritual abuse to get you to conform. If you refuse to conform over time, we will accuse you of having a divisional spirit and ask you to leave and go to hell.

This system looks very attractive from the outside because of the unity of conduct, dress, and doctrine. You may even find congregations of OTVC groups that have very humble, spiritual, caring and loving ministers. But it is a system that is doomed to fail, as it has no working checks and balances. It is a system that has no independent judicial system, no free property, no free press, and no freedom of religion -- it contains all the marks of a dictatorship that imprisons and murders its citizens at will.

A system that is controlled not by the Spirit of God, but by back room meetings with ministers that are only accountable to themselves who are self-appointed judges, juries, prosecutors, police, and prison guards all in one.

They break up families and friends, they embitter the spiritually weak, they destroy the lives of the simple, and they hide sexual criminals -- all in the name of Jesus for the betterment of the "one

One True Visible Church (OTVC) Teaching

Groups that hold the "One True Visible Church" (OTVC) doctrine teach that their group is the only church, that all honest people will come to them, and that God is not working with any other group but them. If they put you out of their fellowship, they hold that you are no longer saved. They would believe the same to be true about any who would leave - no matter what the reason.

Examples of groups that hold this teaching are the Watchtower Society, 2 x 2, Church of Christ groups, Church of God in Christ Mennonite (Holdeman), and Church of God (Restoration). This teaching is used to build a union in conduct, dress, and doctrine. The ministers of these different groups claim they have the authority to cast disagreeing members out of the Body of Christ, and to take away their right standing with God.

The Restoration would feel that it is unfair and unjust to put them in the above list of groups, and I don't want to leave the impression that I am comparing them to the above groups in all areas. The only area where I am comparing them to the other groups in is their OTVC teaching. This is the company they are keeping when it comes to this teaching -- and it is not very good company. Other than the OTVC teaching, the similarities between the Restoration and the above groups end.

The objection of course, will be made that the church that was founded by Jesus was the one true visible church -- and to this I agree. But it was Peter, John, James, Paul and other leaders that were laying out doctrine, holding minister meetings and making decisions, and writing the letters that we hold dearly, not Daniel Warner and Danny Layne -- and this makes a big difference.

Typically, groups that hold the OTVC teaching hold that if you leave their group you are no longer a Christian. The only way you can be re-saved is to come back to the group and meet the requirements that they hold for a person to be saved. While most OTVC groups would hold that there are people outside of their group that are saved, they would feel that if those Christians are presented with their version of the "truth" and they reject it they are no longer saved.

doctor for all medical needs that the law would require them to.

So to answer your question, I do believe there can be perfect unity of the Spirit with other Christians that have a difference in standard for what they believe the Lord has lead them to hold as to what is allowable or not allowable concerning going to the doctor.

I would not break fellowship with someone that believes that they should not go to the doctor to get there teeth fixed or for getting a broken bone fixed or if they hold they shouldn't take medication that will deaden the nerves so there is no pain. Nor would I break fellowship with those that believe it is ok to go to the doctor to save a child or mother during birth, or with some one that believes it is ok to take insulin to control their blood sugar level, or for some one that takes medicine for their bi-polar condition, or with someone that goes to the doctor for an appendectomy.

Further I won't consider people inherently less spiritual for doing the above nor for believing that it is ok before the Lord to do these things. I feel like to break fellowship with brethren over things like this would be the fruit of a sectarian spirit.

When it comes to teachings that the Bible does not give us clear instructions either in precept or by principle we cannot break fellowship with another believer and remain clear with the Lord. When people start cutting off other believers over the standards they have setup that have no support in the Bible by precept or principle they will need to stop professing to be anti-sectarian as they have just become more sectarian than the sectarians.

Since I advised you in Feb of 2007 of my position concerning your teaching the congregation to refuse medical help even if it means dying, you have told me I am not spiritual, implied that I am not sanctified, made me a visitor, have asked be to act like a visitor and implied that I shouldn't call songs in meeting or to pray out in meeting and not long ago you asked me to not share during Sunday school. Further you have told me that I should only testify in meetings that you are present in and when doing that to be short and just to thank God for the one true church.

You have asked me not to pass out literature and you have asked me not to reach out and visit people in the community with the aim of helping them spiritually. And I should note that it is my understand that these above actions you took are not because I am or have received medical care or am taking medicine (as I am not)

but because I hold that it is okay to take medical care in areas that the Restoration teach a person shouldn't.

I want you to know that I strongly disagree with all these steps you have taken and I consider them the fruit of the same sectarian spirit that got a hold of Diotrephes that in its full manifestation caused him to not receive some brethren and to cast others out of the church and slander their Christian experience by claiming there were not spiritual or saved. I say this carefully, prayerfully and not in haste. I believe the Restoration is at risk of being so rule centric that they will become more sectarian than the sectarians by cutting people off and casting them out of the assembly for not keeping rules that we find nothing of in the Bible by way of injunction or principle and the hero's of the Christian faith knew nothing of.

You have no problem going to the doctor for teeth, for getting your bones set, or to take medication to deaden your nerves for these things. You have no problem sending the children and young people from the congregation to the doctor for all things. Yet you hold that some one that thinks it is ok for adults to seek medical care for things you don't allow are not spiritual.

I am not sure how far you are going to take this. Will you soon tell me not to say amen, or to praise the Lord? Will you tell me not to talk to visitors or new Christians? Will you tell me to stop coming to meeting until I change my position? Will you cut me off and tell me I am not saved? How far do you plan on taking this Bro Henry? (These questions are asked in all honesty and are not meant to be sarcastic or disrespectful.)

>>>If the whole body is wrong then you have an obligation to show us by the Bible where it is.

I don't think the whole body of the Restoration is wrong. The Restoration members are just following what the restoration ministry teaches them. Five years ago in most cases it would be considered sinful and wrong to provide medical attention for your children under 18 and if you did you risked being told you had sinned and needed to be saved and for the most part members followed this even to the point of a number of children dieing. Then the ministry changed the rules and told members in US and Canada that they must provide their children with medical attention required by the authorities and the Restoration members now follow that. So my disagreement is not with the Restoration members but with the ministry.

How To Act Toward Those That Do You Wrong

When I was cast out of the Restoration congregation in Aylmer because I disagreed with some of their practices and teaching I determined by the grace of God to not act like they would act toward me (I have been around them for 20 years and I know how they deal with those that leave or they put out).

I would not give railing for railing. I wouldn't be rude toward them when they were rude toward me. I would not unsave them when they unsave me. I would not slander them when they slandered me. I would not shun them when they would shun me.

I would not rejoice when things go wrong for them like they will rejoice when things go wrong for me. I would not paint their conduct in the worse possible way like they will do to me. I will not repeat evil stories I hear about them like they will no doubt repeat those they hear about me. I won't dredge up all their past faults and failures and spread them around like they will of me.

Instead I will with love pray for them, ask God's blessings upon them, continue to brother them, stand up for them when they are misrepresented and slandered, present them in the best light I can, not hold their sins against them but hope their are doing these things in ignorance. When I differed with them it would be only on their doctrine and practices and even then I will testify of all the good teachings and practices they have and all the wonderful truth I have learned from them.

I have determined in my heart to rejoice when they do wrong to me and to forgive them 7 times 70 each day for the rest of my life.

This is the way the Lord would have us to act toward those that abuse us, that cast us out, that count us apostate, that refuse to fellowship us and influence others to do the same – just because we disagree with them on non-essential practices and doctrine.

I expect down the road there will be further changes in the Restoration rules' concerning what is allowed medically and what is not allowed. Personally I think it is only a matter of time before some Restoration parents will be charged with voluntary manslaughter of an unborn child for recklessly manifesting extreme indifference to the life of their unborn child (that is how the charge is worded legally). At that point I expect the Restoration medical allowance rules will change. I would strongly suggest you act proactively and make this change in the rules before that comes about by requiring all expecting mothers to use the option of medical intervention where the life of the child is at risk and to employ experienced midwives (overseen 100's of births) for all births.

If the police had known all the facts in the failure of our home birth which caused the death of our son Levi, Susan and I could have been easily charged with voluntary manslaughter and I shamefully admit I feel like at least I would have been guilty. I have had to repent before the Lord for what the Restoration rules influenced me to do in that situation and Susan is still suffering emotionally and physically from that ordeal which is now 8 years ago.

As far as me having an obligation to show you where you are wrong by the Bible I think that is very easy to do.

The Restoration teaches those that receive most medical procedures and take most medicines are showing a lack of spirituality and faith in God and are either living below the Bible standard or for those who have been in the Restoration long enough to know and accept what the Restoration teaches for divine healing have committed sin.

If the Bible teaches that it is wrong and sinful to have medical procedures or to take medicine then you can't make exceptions unless the Bible gives them by direct injunction or by principle. An example of a Biblical principle that forbids a medical procedure is where alcoholic wine is subscribed for thinning the blood of those that are in risk of blood clotting. Proverbs 20:1 says wine is a mocker, strong drink is raging.

If you maintain that there are scriptural principles in the Bible that will help people decide what procedures are allowed and which ones are not I would ask you where the principle is in the Bible that would leave a person with the conclusion that the removal a deep rooted wisdom tooth with minor surgery is allowed by God but the removing a child for the womb with minor surgery is sinful.

When an exception is made for some people for all medical procedures and for all people for some medical procedures you have to provide clear injunctions or principles from the Word of God to deem the exceptions Biblically based. If you can't show support in the Bible for the exceptions you make either by clear injunction or by principle the teaching is weighted and found wanting.

In fact when we weight this teaching by the Word we will find principles that stand against this teaching. The Restoration teaches that all children under 18 are to be given all the medical procedures that are required by law in US and Canada.

The Bible teaches in principle that we are to train up a child in the way they should go. If taking medical care and medicine is sinful then this Bible principle teaches that no matter what we should not do this. It is human reasoning that teaches that we do the lesser of two evils. It is evil to take medicine but it is more evil to loose you children to the government's control so the Restoration chooses the lesser of the two evils. This is a good example of basing a teaching by human reasoning and not by Biblical injunction and principle. The very thing the Restoration claims they don't do.

Also I will point out that when the Restoration taught that it was wrong and sinful to give medical attention to children and children died because of that practice I was in disagreement and I voiced my objections to Bro. Layne. I rejoiced when that rule was changed and I consider the changing of that rule to be an admission of the Restoration being wrong and my position being right. As God never makes any exceptions with sin it is clear that the Restorations non-medical rule with it numerous exceptions is a man made set of rules that finds no support in the Bible at all.

Now let me ask you a question Bro Henry, and I do this with all respect, how can you feel clear in your soul making and enforcing rules that are not Bible based and tell people if they don't keep them they are sinning?

I shared my amazement with you about one and a half year ago when I was working on your computer in your home office and you asked me what I would do with members that were disobeying the ministries counsel to not go on the Internet. At that time I told you I don't see how you can tell a person they are sinning for going on the Internet when you yourself are going on the Internet on regular bases yourself. How can you charge a person with sin for doing the very same thing you are doing?

I again voice my amazement on how a rational thinking person can go to the doctor and get teeth work done and take medication (local anesthetic) , hold that it is ok to go to the doctor to get broken bones set and take medication (local anesthetic), hold that it is ok for children and young people to under 18 to go to the doctor for any medical need and then turn around and tell a mother giving birth that has complications that it is sinful and wrong for her to go to the doctor. Brother Henry we had a conversation back in Feb of 2007 and at that time I told you clearly where I stood and how I came to that

position after prayer, fasting, and searching the Word of God. I let you know that I believed that teaching mothers-to-be to consecrate to die in childbearing before accepting medical help in the case of complications was a ludicrous position to hold.

To your suggestion that I pray for more faith and that I admit to lacking faith in divine healing I was very up front and honest with you. I told you I was not seeking further understanding on that point as I felt like the Lord had clearly showed me that what the Restoration was teaching for divine healing was not Biblical. This has not changed.

>>>Most of the time I have found that when a person is in disagreement with the body on a mayor point, there are usually other areas that need attention.

I have gone on record with different ministers down through the years concerning a number of things that the Restoration and Faith & Victory teaches that I don't think are supported by the Bible. I disagree with the following positions the Restoration takes:

- Believe what ever the ministry teachings without questioning it;
- follow counsel given by the ministry even if you don't understand it;
- that the Restoration will never compromise;
- that no Christians will be left in any denominations and they will only be found in the Restoration before the Lord comes back;
- the back dating of the fall of the church to 270 by holding that the three days and a half of Rev 11 are 350 years and that God purposely using the day symbol in this way so that many people would not accept the 270/1880 dates;
- that not keeping Restoration rules is sin and causes you to lose your salvation;
- ministers going on Internet while telling others it is sin to do the same;
- being less that forthcoming and purposely leaving authorities with wrong impressions concerning deaths where members refused medical help;

--that the Restoration is prophetic and therefore can do no wrong;

--the hiding of divorce/remarriage and the anti-medical teaching from visitors and new members;

--teaching that when you praise the Restoration you are really praising Jesus as the Restoration is Jesus' body;

--attributing the accepting the Restoration as the church, obeying the Restoration ministry, and keep all the Restoration rules as spirituality verses having a deep devotional life, an active burden for souls, a consistent increase in the fruit of the Spirit, and freedom from carnality;

--teaching and encouraging members to praise the ministry verbally in meetings;

--teaching that we are to be married to the Restoration;

--teaching a standard of dress that is not based on modesty only but also based on distinction for the sake of being distinct and noticed;

--a low standard of sanctification that allows for carnality in the sanctified;

--and of course the anti-medical teaching.

There probably are a number more but they have no practical implications and they are just minor nit picky issues that would serve no purpose at all in being raised.

I don't consider any of these mayor points of Christian doctrine. Most of these issues are just part of having a radical end times teaching, an authoritarian ministry, being movement centric, and being non-conformist with a lot of unwritten rules. I am however concerned with what I have seen where members and ministers appear to have become loose with the truth and have purposely left authorities with incorrect impressions that I feel like in some cases could be seen by some as lying. Also I am equally concerned that we don't fall into movement and ministry worship as spiritual pride will destroy any movement. Then of course I disagree with the anti-medical teaching.
